This Pomeranian puppy/dog is being sold for the price of \$ _____. Deposits are non-refundable. In addition, all expenses for preparation to ship plus shipping expenses are the responsibility of the buyer. The breeder/seller must receive full payment by the time of taking possession of the puppy/dog. This puppy/dog is sold with no warranties, either expressed or implied in as is condition with no guarantees other than those stated herein. Breeder/Seller cannot guarantee adult size, adult coat color, or coat quality /quantity.

This Pomeranian is being sold as a "Show Prospect" with Full AKC registration papers. "Show Prospect" is defined as not having "major faults" as defined in the AKC breed standard for his/her age on the date of sale. Breeder/Seller will guarantee a correct (finishable) bite regarding dentition for AKC. Breeder/Seller will guarantee males to have two testicles descended into the scrotum at maturity.

The new owner has three (3) business days from the date of taking possession of the puppy/dog to have the puppy examined by a veterinarian of their own choice, at their own expense. If the vet exam reveals that the puppy/dog is diseased or has a genetic defect, the buyer must contact the breeder/seller on the day of the veterinary office visit. The puppy/dog must be returned to the breeder/seller within four (4) days, along with a written statement from the attending veterinarian regarding the health problem. A replacement puppy/dog will be provided when one becomes available. Replacement is the only option. Returning the puppy/dog will be at the buyer's expense. There is no guarantee against accidents. No veterinary bills will be paid by the Breeder/Seller. Breeder/Seller has the option of refunding the purchase price of the puppy/dog if a replacement will not be available in the foreseeable future. To the best of Breeder's/Seller's knowledge, this puppy/dog is free of disease and defects at the time of transfer.

Buyer understands and agrees that when this puppy/dog leaves the breeder's/seller's possession the Buyer is responsible for the life, health and well being of this animal. It is agreed that at no time will the owner sell or give this puppy/dog to a pet store, a puppy mill operation, a dog pound, a dog broker, or any similar enterprise. In the event that the owner needs to find a new home for the puppy/dog, the breeder/dog should be contacted for possible assistance.

Having read the above, and with full understanding of the contents herein, I willingly enter into this agreement. Breeder/Seller and Buyer agree that if litigation arises out of this sale transaction, suit must be brought in the County and State in which the Breeder/Seller resides at the time suit is filed.
